I acknowledge and agree that both AEBC, and the Company shall have access to all records arising out of usage of my Corporate Card account. I understand, agree and undertake that upon issuance of the Corporate Card, I will be liable for all charges incurred on it. I am also aware and agree that the company shall be jointly and severally liable for charges, as provided in such conditions of the Corporate Card Account Membership. I declare and undertake that the Corporate Card issued to me if used overseas shall be utilized strictly in accordance with the relevant Exchange Control Regulation and guidelines, issued and the amended by the Reserve Bank of India ("RBI") from time to time. In the event that I exceed my entitlements as per the Exchange Control Guidelines of the RBI, I undertake to bring the same immediately to the notice of AEBC in writing. Further I also agree and understand that if I am required to get my passport endorsed for any such charges incurred me as stipulated by RBI, the onus of getting the passport endorsed shall be entirely on me. And in the event of any failure to comply with the prevailing Exchange Control Guidelines issued by RBI by me, I will be liable for any action under the Foreign Exchange Management Act, 1999 as amended, and be debarred from the Corporate Card facility either at AEBC's instance or by the RBI. I understand that my Corporate Card will be issued at the sole discretion of AEBC and if approved will be delivered to me within 15 working days of my application being received by American Express.
